

Pioneer Foods and Feedem Group (Pty) Ltd Win a hamper with Pioneer Foods products Competition rules

1. The Promoters are Pioneer Foods Groceries (Pty) Ltd and Feedem Group (Pty) Ltd, trading as Feedem (“Feedem”) together referred to as The Promoters.
2. The competition is open to all South African Residents above the age of 18, except directors, members, partners, employees, agents or consultants of or any other person who directly or indirectly controls or is controlled by the Promoters or marketing service providers in respect of the promotional competition, or the spouses, life partners, business partners or immediate family members, or anyone who within a period of 183 days preceding this competition has won any competition organised, promoted, or conducted by Promoters, trading as Feedem, or who resides at the same address as such a winner, or who uses the same telephone number to enter this competition.
3. This competition is open from **1 June 2018 – 15 July 2018 (“last day”) in the Gauteng Region Only at selected participating Canteens**. Any entries received after midnight on the last day will not be valid and not be considered.

To enter, buy a Lipton Ice Tea 330ml or Liqui Fruit 330ml or Fruitree 330ml at selected Feedem Group (Pty) Ltd, trading as Feedem, simply write your name and contact details on the back of your till slip, then drop it into the entry box displayed in the selected outlet (details of the selected canteen to be obtained from the Feedem Group (Pty) Ltd).
5. The winner will be selected at random by way of a draw conducted by the Promoters or a person appointed by the Promoters and the prize of 1 x hamper with Pioneer Foods products to the value of R200 (two hundred rand) at the selected canteen.
6. The draw will take place between 16 July 2018 and 20 July 2018 and the winners will be notified by telephone between 16 July 2018 and 20 July 2018. The organisers will endeavour to contact the prize winners on the telephone number provided.
