

## Pioneer Foods and Ukweza Holdings (Pty) Ltd Win a hamper with Pioneer Foods products Competition rules

1. The Promoters are Pioneer Foods Groceries (Pty) Ltd and Ukweza Holdings (Pty) Ltd together referred to as "The Promoters".
2. To enter, buy a Liqui Fruit Juice 250ml or Ceres 200ml or a SAFARI Snack bar at selected Ukweza Holdings (Pty) Ltd canteens, and write your name and contact details on the back of your till slip, then drop it into the entry box displayed in the selected outlet (details of the selected canteen to be obtained from Ukweza Holdings (Pty) Ltd).
5. The winner will be selected at random by way of a draw conducted by the Promoters or a person appointed by the Promoters and the prize of 1 x hampers with Pioneer Foods products to the value of R200 (two hundred rand) will be handed out to the winner at the selected canteen.
